

AAPRA is established by resolution during NRPA Congress in Phoenix, AZ – October 22

1981 President Frank Vaydik * NRPA Minneapolis

AAPRA Bylaws approved and objective established. **Frank Vaydik** elected first president of AAPRA. **Legends in Parks and Recreation program** proposed by Bob Toalson and the first interviews taped: Dr. Edith Ball, Conrad Wirth, John Schultz, Robert Crawford and Clifton French
