Our Name: The American Academy for Park and Recreation Administration

A Brief Historical Review:

- Late 1970's conversations were held about lack of opportunities for seasoned park & recreation administrators (professionals & educators) to provide professional services & fellowship
- Frank Vaydik, President, AIPE (American Institute of Park Executives; one of the organizations who merged to create NRPA in 1966), Director, Kansas City, MO, organized a meeting in 1980 of seasoned administrators & educators to discuss forming an academy
 - 29 attendees pledged \$100 each to form the American Academy for Park & Recreation Administration
 - Many founders were past NRPA Presidents
- 1981 bylaws were presented & unanimously approved
- Numerous projects have been launched by AAPRA
- Celebrated our 40th Anniversary (2020-2021) Academy's history is posted on the website under "About AAPRA"



AAPRA'S FIRST PREAMBLE

GUIDES US TODAY "We, the concerned parks and recreation professionals in America, in order to promote understanding of parks and recreation goals and methods, to increase knowledge through encouraging its gathering, organization and dissemination, and to unify and strengthen our our purposes, all toward improving the quality of life in America, do hereby decree the establishment of an Academy of illustrious parks and recreation fellows to undertake this charge."

LEADERSHIP OF AND FOR PUBLIC PARKS AND RECREATION

MEMBERSHIP DETAILS

- Three categories of Fellows:
 - Practitioners (limit 100) and Educators (limit 25)
 - Urban Directors (limit 10% of total membership or 12)
 - Emeritus (no limit); as members retire, they transition to this category
- Membership year January December
- Dues: invoiced in January 2025; due within 30 days; pay online or with check
 - \$325 Practitioners / Educators / Urban Directors
 - \$110 Emeritus

ADVANCING KNOWLEDGE

- Commission for the Accreditation of Park & Recreation Agencies (CAPRA) / partner NRPA
 - 203 park and recreation agencies & military installations are CAPRA accredited
 - CAPRA meets annually to review agency applications / re-applications
 - Commission comprised of AAPRA, NRPA, & other appointees
 - AAPRA appoints 5 Representatives to the Commission
- Extern Program, focus is on mentoring young professionals at NRPA
 Conference, we provide financial assistance to support their attendance
- Mentoring Program, focus is on mentoring professionals for 6 months (or more) virtually, in person, or by email; work with NRPA's YPN
- American Parks & Recreation Foundation (APRF), a separate organization which provides scholarships to professional development schools; members are asked to make a separate donation to APRF



PROMOTING BROADER UNDERSTANDING OF PARKS AND RECREATION

- National Gold Medal Award Program / governing organization & administrator / sponsor Musco Lighting
 - Recognizes excellence in management of parks & recreation agencies, state park systems, & military installations around the world
- Legends in Parks & Recreation / partner Landscape Structures, LLC
 - Video Recordings of Leaders in P&R
 - Academy membership is NOT required to nominate or to be nominated
 - Recorded & posted on website
 - Themed videos are also available
- Recreation & Park Hall of Fame / partner NRPA
- The Honorable Cornelius Amory Pugsley Award / partners Davey Tree Expert Company & National Park Foundation
 - Honors individuals for lifetime achievements in parks and conservation
 - Academy membership is not required to nominate or to be a nominee



ENCOURAGING SCHOLARLY EFFORTS


- Academy produces JPRA: Journal of Park & Recreation Administration / publisher Sagamore-Venture Publishing
 - Subscription included in your membership
- Best Paper Award: Master or Dissertation
 - Annually (alternating years) / cash prize to author
- Research Committee: Committee conducted surveys
 which identified research needs of practitioners;
 developing pilot program to link administrator's needs
 with researchers who have expertise in those areas
