Nominations for Academy Membership

High level positions may be general manager, executive director, director, deputy director, superintendent with significant experience and oversight in parks, recreation, personnel, training, budgeting, planning, capital improvements, and marketing. Educator nominee must have attained the rank of full professor or served in a high level of academic administration. Practitioner and educator nominees must also be recognized as a leader through professional involvement, publications, major presentations, and honors and awards.
